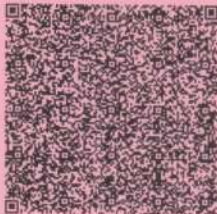

- Department of History, Bharathidasan Government College for Women, (Autonomous), Puducherry through this MOU seeks favourable opinion and helps in formulation of syllabus, designing of course materials as well as expertise help towards us and our students in imparting training in different aspects of museology.
